**Call to Order**

Mr. Huffman called the meeting to order at approximately 12 noon and asked Mr. Judson to begin the meeting with a prayer.

**Take Action on Trustee Resignation**

Mr. Huffman announced that Trustee James D. Price has moved to a new residence not located within the boundaries of Precinct Three, which he was elected to represent. As a result, Dr. Price has submitted a letter of resignation vacating his seat on the Board of Trustees and office of Vice Chairman, effective immediately.

Mr. Huffman continued by reading the resignation letter aloud. In his letter, Dr. Price praised Navarro College for its outstanding Board of Trustees and staff and that he was resigning with deep sadness. He concluded by stating he would continue to support Navarro College in any way possible.

Mr. Aldama made a motion to accept Dr. Price's resignation with "deep regret" and Mr. Judson seconded the motion. Mr. Judson stated Dr. Price "led with great authority, wisdom and a sense of humor and will be missed." The motion to accept the resignation passed by a unanimous vote.

Mr. Huffman stated he wished Dr. Price good luck and that he was "very progressive about getting things done" and will be missed. Dr. Kavalier announced plans to recognize Dr. Price for his service at the February Board meeting.

Mr. Huffman announced the next regular meeting of the Board of Trustees will be held on February 26 in the Cook Education Center.

Mr. McGraw moved to adjourn the meeting at 12:05 p.m. and Mr. Aldama seconded the motion. The decision to adjourn was unanimous.
