SEPTEMBER 30, 2021 PUBLIC HEARING ON SETTING
AD VALOREM TAX RATE FOR 2021 (FY2021-2022)
MINUTES

The governing body gathered in the Bulldog Board Room located in Walker Dining Hall on the Corsicana Campus at 5:00 p.m. on Thursday, September 30, to conduct a public hearing on the intent to set the 2021 (FY 2021-2022) ad valorem tax rate. Chairman Judson called the Public Hearing to order at 5:00 p.m. in the Bulldog Board Room. He announced during the August 19, 2021 meeting, Navarro College Board of Trustees declared its intent to set the Ad Valorem Tax Rate for Calendar Year 2021 (Fiscal Year 2021-2022) at the current rate of \$0.1164 per \$100 of taxable value. The proposed tax rate exceeds the "no-new-revenue" tax rate but does not exceed the "voter-approval" tax rate as prescribed by Tax Code 26.06(b-2). In accordance with Tax Code statutes, a notice was published in the Corsicana Daily Sun and this public hearing was scheduled to hear comments from any Navarro County community members on the Board's intent.

Chairman Judson opened the hearing for anyone wishing to address the Board. There were no requests to address the Board.

Trustee Atkeisson made motion to adjourn the public hearing and Trustee Aldama seconded motion. The motion to close the hearing passed by a unanimous vote.

The public hearing was adjourned at approximately 5:03 p.m.

Following adjournment of the public hearing, the Board of Trustees remained in the Bulldog Board Room for a Cybersecurity Training session. The mandatory training session was conducted by Barry Sullivan, Director of Information Technology and concluded at 5:50 p.m.
