***Public Hearing Related to the Intent to Set the Ad Valorem Tax Rate for Calendar Year 2010 (Fiscal Year 2010-2011) at \$0.119 per \$100 Assessed Valuation***

No member of the public was present to address the board regarding their intent to set the ad valorem tax rate at \$0.119 per \$100 assessed valuation. This was the first of two scheduled public hearings as required by law.

***Adopt Amended Resolution Authorizing the Sale of College Property Located in Downtown Mexia, Texas to Limestone County Senior Services Project***

Dr. Sanchez stated the board had previously adopted a resolution for the sale of college property located in downtown Mexia for \$100 to the Limestone County Senior Services Project. He stated there were a few minor issues with the property's title that have been resolved. However, the attorney overseeing the sale has requested the board adopt a revised resolution with the legal description of the property being sold.


Mr. Atkeisson made a motion to adopt the revised resolution and Mr. Aldama seconded the motion. The vote was unanimous.
